# PROCLAMATION HONORING THE WADLEY HIGH SCHOOL BULLDOGS FOOTBALL TEAM ON THEIR 1A STATE CHAMPIONSHIP WIN



WHEREAS, the Wadley High School Bulldogs is a football team located in the Town of Wadley; and,

WHEREAS, the Town of Wadley is located inside the County of Randolph; and,

#### AGENCY AGREEMENT

The Randolph County Commission hereby authorizes the Alabama Secretary of State to act as its agent for the purposes of paying postage necessary and performing the mailing of certain notices pursuant to the National Voting Rights Act of 1993 to voters as required by Act 2021-534 and collecting reimbursements from the State Elections Fund. The County Commission understands that the Secretary of State will be paying postage on the voter notifications required by §17-4-30(a), Code of Alabama (1975), from monies the County is entitled to for such costs from the State Elections Fund pursuant to §17-4-31, Code of Alabama (1975). The County Commission also agrees that the business reply mail account fee and business reply postage charges will remain its responsibility for which it may be reimbursed by the State of Alabama under the normal operation of the Act.
