This budget amendment will result in the use of \$374,400 of General Fund savings, which was designated on 2/27/2023 for the purposes of building a logistics building for the voluteer fire association.



RESOLUTION 2024-12A FOR THE EXPENDITURE OF AMERICAN RESCUE PLAN ACT FUNDS FOR GOVERNMENT SERVICES



WHEREAS, Randolph County, Alabama (the "County") has received American Rescue Plan Act fiscal recovery funds ("ARPA funds") and is charged with ensuring that such funds are expended in accordance with state and federal law; and

WHEREAS, under the Final Rule published by the United States Department of Treasury dated January 6, 2022, the County has designated standard allowance of up to \$10,000,000 of its ARPA funds, not to exceed the County's total ARPA funds award, as revenue replacement ("Revenue Replacement funds"); and

WHEREAS, the County may expend designated Revenue Replacement funds for government services; and

WHEREAS, the County has determined that there is a need to renovate the courthouse and annex buildings to best accommodate its employees and provide effective and efficient services for its citizens; and

WHEREAS, the County has determined that renovations to the courthouse and annex buildings, including upgrades to the mechanical systems and renovations to spacing to encourage efficient and safe traffic flow throughout the buildings (the "Project"), are a necessary, reasonable, and proportionate measure to facilitate the provision of these government services; and

WHEREAS, by way of resolution dated September 12, 2022, the Commission approved the allocation of Revenue Replacement funds to cover design fees for the project; and

WHEREAS, consistent with the Public Works law, the County issued an invitation to bid for construction services for the Project, in which one (1) bid was received from Forsyth Building Company; and

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION as follows:

- 1. The County shall use its remaining obligated Revenue Replacement funds, estimated at \$3,341,381 to facilitate the provision of the government services to cover reasonable costs of the project.
- 2. The County Administrator is hereby authorized to expend these funds to purchase goods and services as described herein from appropriately procured vendors to facilitate the provision of these services.
- 3. The ARPA Program Director is charged with ensuring that Revenue Replacement funds allocated and expended to provide these government services will not be used in such a way as to frustrate COVID-19 mitigation guidance issued by the Centers for Disease Control, or for any other use prohibited by the Final Rule or any applicable state or federal law.

4. Expenditure of these funds, as authorized by this Resolution, shall be contingent on the continued appropriation and availability of ARPA Revenue Replacement funds for this purpose and in no event shall be used for any expenses not obligated by December 31, 2024, and expended by December 31, 2026.
