

PUBLIC NOTICE

The Randolph County Commission is considering the feasibility of closing (vacating) a section of County Road 417, in the area of Smyrna Church being more particularly described as follows:

Commencing at the intersection of County Road 473 and County Road 417, thence run north along said County Road 417 (an unpaved roadway) a distance of 0.247 miles for a point of beginning, thence continue on said County Road 417 a distance of 0.437 miles to the boundary of Section 24 and Section 13 for a point of ending (0.200 miles south of the intersection with County Road 92).

Said roadway lying in Section 24/Section 13, Township 18 S, Range 11 E, and Section 18, Township 18 S, Range 12 E Randolph, County Alabama.
